Terms and Conditions are listed as follows:

There are absolutely no guarantees other than those listed below and NO Genetic Health Guarantee is included on the purchase of an ADULT DOG (over the age of 8 mos)

To the best of my knowledge this dog is in good health at the time of delivery. The buyer must have the above referenced dog examined by a licensed veterinarian within three (3) days from purchase. The expense of this examination is to be assumed by the buyer. If the dog is found to be in-sound it can be returned for refund of purchase price or a replacement pup of equal value. Either one is at the breeders discretion. This is provided the pup is returned within the 3 day period and is accompanied by a letter from the examining veterinarian stating in what respect the dog is unsound. The guarantee is VOID should the buyer not have the dog examined within the 3 day period.

An AKC registration number is associated with this puppy, but until proof of spay/neutering for Limited Registration, the registration paperwork is retained by the Breeder. Once proof has been obtained, either electronically or hardcopy, the registration paperwork will be sent promptly.

There will be NO refund by the seller/breeder for any reason including: hernias, retained testicles, allergy, mortality, landlords disapproval, disagreement of family or any other problems. Additionally, illness caused by neglect, exposure to weather, injury, choking, or poisoning are also not part of this guarantee. No warranty or guarantee is made to the disposition, life-span, size, color, show quality, or Breeding ability/quality of any dog/puppy.

THE BREEDER WILL NOT BE LIABLE FOR ANY EXPENCES INCLUDING BUT NOT LIMITED TO: Any Veterinary Bills, Transportation, or other expenses. Should there be a life threatening genetic defect in a puppy under 8 mos old having been there since birth, and diagnosed by a licensed veterinarian, the breeder/seller will refund or replace the puppy, limited to FIVE YEARS from the date of purchase. NO refund or replacement will at any time be made on a deceased puppy until an autopsy is performed to determine cause of death. Such an autopsy must be performed by an accredited institution set up for such procedures. Autopsies performed by a local veterinarian will not be accepted. All expenses will be paid by the owner of the pup. The results of the autopsy will accompany any request for replacement or refund. The breeder/seller must be notified immediately upon discovery of a genetic defect. The breeder/seller reserves the right to have the pup examined by a veterinarian of her choice for a second opinion. In the case of a discrepancy between a genetic and acquired condition the seller/breeder has the sole and absolute final decision. Should the pup be returned, the seller/breeder will only refund the purchase price of the pup, not including transportation, vet check, gas, air fare, or supplies. NO VET BILLS WILL BE REIMBURSED. IF YOU ARE PURCHASING AN ADULT DOG OVER THE AGE OF 8 mos THERE IS NO GENETIC GURANTEE FOR ADULT DOGS.

ACCEPTANCE OF THE PUPPY/DOG CONSTITUTES ACCEPTANCE OF THIS CONTRACT IN FULL.

I UNDERSTAND THAT IF AT ANY TIME DURING THE LIFE OF THE PUPPY/DOG I AM NO LONGER WILLING OR ABLE TO PROVIDE PROPER CARE OR AFFECTION FOR HIM/HER, I AM TO RETURN (AT MY OWN EXPENSE) SAID PUPPY TO WISHBONE FARMS SCHNAUZERS---- NO QUESTIONS WILL BE ASKED AND NO ASSUMPTIONS WILL BE MADE ABOUT YOU-----THIS PUPPY WILL BE PLACED IN A PET HOME OR WILL STAY AT WISHBONE FARM SCNAUZERS. I UNDERSTAND THAT BY SURRENDERING THE PUPPY IN SUCH A MANNER I AM RELINQUISHING ALL RIGHTS, EXPECTATIONS, AND MONETARY REWARDS OR OBLIGATIONS ASSOCIATED WITH THIS PUPPY, BOTH AT THE TIME OF THE SURRENDER AND IN THE FUTURE. THIS PUPPY IS NEVER TO BE PLACED IN ANY SHELTER. IF YOU ARE NO LONGER ABLE TO KEEP YOUR PUPPY AND CHOOSE TO PLACE HIM/HER YOURSELF, YOU MUST NOTIFY WISHBONE FARM SCHNAUZERS OF ITS PLACEMENT AND THE NEW
